## TRADEMARK SECURITY AGREEMENT

TRADEMARK SECURITY AGREEMENT, dated as of May 31, 2005, by DIRECT HOLDINGS AMERICAS INC., a Delaware corporation (the "Grantor"), in favor of The CIT Group/Business Credit, Inc. ("CIT"), as agent for the Secured Parties (as defined in the Financing Agreement referred to below) (in such capacity, the "Agent").

WITNESSETH:

WHEREAS, pursuant to the Term Loan B Financing Agreement, dated as of May 31, 2005 (as the same may be amended, restated, supplemented or otherwise modified from time to time, the "*Financing Agreement*"), by and among the Grantor, Direct Holdings Custom Publishing Inc., a Delaware corporation ("*DH Custom*"), Direct Holdings Education Inc., a Delaware corporation ("*DH Education*"), Alex Inc., a Delaware corporation ("*Alex*"), Direct Holdings.Com, Inc., a Delaware corporation ("*Direct Holdings.com*"), Direct Holdings Customer Service, Inc., a Delaware corporation ("*DH Customer*"), Direct Holdings Libraries Inc., a New York corporation ("*DH Libraries*" and, together with the Grantor, DH Custom, DH Education, Alex, Direct Holdings.com and DH Customer, the foregoing collectively, the "*Borrowers*"), Direct Holdings U.S. Corp., a Delaware corporation ("*Holdings US*"), Direct Holdings Worldwide L.L.C. (formerly known as LVC Holdings L.L.C.), a Delaware limited liability company (the "*Parent*"), each Subsidiary of the Parent listed as a "Guarantor" on the signature pages thereto (together with the Parent and Holdings US, each a "*Guarantor*" and collectively, the "*Guarantors*"), CIT and the other financial institutions party thereto from time to time as Lenders (the "*Lenders*"), and CIT, as agent for the Lenders (in such capacity, the "Agent"), the Lenders have severally agreed to make a tranche B term loan to the Borrowers upon the terms and subject to the conditions set forth therein;

WHEREAS, pursuant to the Financing Agreement, each Borrower has guaranteed the Obligations of each other Borrower and each Guarantor is party to a Guaranty pursuant to which it has guaranteed the Obligations of all Borrowers; and

WHEREAS, all the Borrowers (including the Grantor) and the Guarantors are parties to a Pledge and Security Agreement of even date herewith made in favor of the Agent (the "*Pledge and Security Agreement*") pursuant to which the Grantor is required to execute and deliver this Trademark Security Agreement;

NOW, THEREFORE, in consideration of the premises and to induce the Lenders and the Agent to enter into the Financing Agreement and to induce the Lenders to make their respective extensions of credit to the Borrowers thereunder, the Grantor hereby agrees with the Agent as follows:

### ***Section 1. Defined Terms***

Unless otherwise defined herein, terms defined in the Financing Agreement or in the Security Agreement and used herein have the meaning given to them in the Financing Agreement or the Security Agreement.

### ***Section 2. Grant of Security Interest in Trademark Collateral***

The Grantor, as collateral security for the full, prompt and complete payment and performance when due (whether at stated maturity, by acceleration or otherwise) of the Secured Obligations of the Grantor, hereby collaterally assigns, conveys, mortgages, pledges, hypothecates and transfers to the Agent for the benefit of the Secured Parties, and grants to the Agent for the benefit of the Secured Parties a Lien on and security interest in, all of its right, title and interest in, to and under the following Collateral of such Grantor (the "*Trademark Collateral*"):

all of its Trademarks and Trademark Licenses to which it is a party, including, without limitation, those referred to on *Schedule I* hereto;

all goodwill of the business connected with the use of, and symbolized by, each Trademark and each Trademark License;

all reissues, continuations or extensions of the foregoing; and

all Proceeds of the foregoing, including, without limitation, any claim by Grantor against third parties for past, present, future infringement or dilution of any Trademark or Trademark licensed under any Trademark License or (ii) injury to the goodwill associated with any Trademark or any Trademark licensed under any Trademark License.

#### ***Security Agreement***


The security interest granted pursuant to this Trademark Security Agreement is granted in conjunction with the security interest granted to the Agent pursuant to the Security Agreement and the Grantor hereby acknowledges and affirms that the rights and remedies of the Agent with respect to the security interest in the Trademark Collateral made and granted hereby are more fully set forth in the Security Agreement, the terms and provisions of which are incorporated by reference herein as if fully set forth herein.


