**TRADEMARK RELEASE**

WHEREAS, the Assignor has heretofore granted to the Collateral Agent a security interest in certain United States trademarks, trademark registrations and trademark applications as more particularly set forth on Schedule A attached hereto (the "Marks") to secure the Obligations of the Assignor, as such term is defined in the in the Security Agreement among the Assignor, the other assignors from time to time party thereto and the Assignee, dated as of June 28, 2002 (as amended from time to time, the "Security Agreement"); and

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, the Collateral Agent hereby releases, discharges, quit claims and relinquishes unto the Assignor any and all right, title and interest in and to the Marks, and more particularly, (i) the security interest in the trademarks, trademark registrations and trademark applications as set forth on Schedule A hereto, (ii) all Proceeds (as such term is defined in the Security Agreement) and products of the Marks, (iii) the goodwill of the businesses with which the Marks are associated and (iv) all causes of action arising prior to or after June 28, 2002 for infringement of any of the Marks or unfair competition regarding the same, and granted to


Collateral Agent by the Assignor by the Security Agreement, which Assignment was duly recorded on July 12, 2002 at Trademark Reel 2551, Frame 0634 in the United States Patent and Trademark Office.
