GRANT OF SECURITY INTEREST IN TRADEMARKS

GRANT OF SECURITY INTEREST IN TRADEMARKS, dated as of June 15, 2005, from **NORWOOD PROMOTIONAL PRODUCTS, INC.**, a Delaware corporation ("**NPPI**"), each of the direct and indirect subsidiaries of NPPI (collectively the "**Grantors**"), to **THE BANK OF NEW YORK**, as Administrative Agent for the lenders or other financial institutions or entities party, as lenders, to that certain Second Amended and Restated Security Agreement ("**Security Agreement**") dated August 16, 2004 (the "**Grantee**").

WHEREAS, the Grantee is the successor Administrative Agent to U.S. Bank National which was the successor Administrative Agent to Bank of America, N.A. which was the successor Administrative Agent to NationsBank, N.A.;

WHEREAS, Grantors are the owners of all right, title and interest in, to and under the trademark property, trademark registrations and pending applications for registration set forth on Schedule A attached hereto (the "**Marks**");

WHEREAS, Grantee desires to acquire a security interest in, and lien on, all of Grantors' right, title and interest in and to the Marks; and

WHEREAS, Grantors are willing to grant to Grantee a security interest in and lien upon the Marks.

NOW, THEREFORE, for good and valuable consideration, the sufficiency and receipt of which is hereby acknowledged, and subject to the terms and conditions of the Security Agreement, Grantors hereby grant to Grantee a first security interest in, and a lien upon, all of Grantors' right, title and interest in, to and under the Marks, including, without limitation, all certificates of registration thereof, supplemental registrations thereof or acquired in the future, and including, but not limited to, all ownership, treaty and convention, moral, attribution and/or integrity rights associated therewith, all renewals and extensions thereof, the right to recover for all past, present and future infringements thereof, and all other rights of any kind whatsoever accruing thereunder or pertaining thereto.

This Grant of Security Interest in Trademarks is made to secure the satisfactory performance and payment of all the Secured Obligations (as such term is defined in the Security Agreement) of the Grantors.


