RELEASE OF TRADEMARK SECURITY AGREEMENT

THIS RELEASE OF TRADEMARK SECURITY AGREEMENT is given as of this third day of February, 2004 by GENERAL ELECTRIC CAPITAL CORPORATION, a Delaware Corporation ("Assignor"), to CARMIKE CINEMAS, INC., a Delaware corporation ("Assignee"), as follows:

WHEREAS, Assignor and Assignee entered into a Trademark Security Agreement, dated as of January 31, 2002 (the "Security Agreement"), which was recorded in the United States Patent and Trademark Office at Reel 2458, Frame 0946, pursuant to which Assignee granted to Assignor a continuing first priority security interest in all of its right, title and interest in, to and under (a) all of its Trademarks and Trademark Licenses (as such terms are defined in the Security Agreement) to which it is a party, including those referred to on Schedule I hereto, (b) all reissues, continuations or extensions of the foregoing, (c) all goodwill of the business connected with the use of, and symbolized by, each Trademark and each Trademark License; and (d) all products and proceeds of the foregoing, including, without limitation, any claim by Grantor against third parties for past, present or future (i) infringement or dilution of any Trademark or any Trademark licensed under any Trademark License, or (ii) injury to the goodwill associated with any Trademark or any Trademark licensed under and Trademark License (collectively, the "Trademark Collateral");

WHEREAS, Assignee has fully satisfied all of its obligations under the Security Agreement and Assignor desires to release its security interests in and liens upon the collateral pledged pursuant to said Security Agreements, including, but not limited to, the Trademark Collateral;

NOW THEREFORE, FOR VALUE RECEIVED, Assignor, does hereby grant, assign and convey absolutely, and release any security interest, lien or collateral assignment in the Trademark Collateral to Assignee, WITHOUT ANY REPRESENTATION OR WARRANTY OF TITLE AND WITHOUT RECOURSE.
