**ASSIGNMENT BACK AND RELEASE  
OF SECURITY INTEREST IN INTELLECTUAL PROPERTY**

THIS ASSIGNMENT BACK AND RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY is made and entered into this 30th day of June, 2005 from **NATIONAL CITY BANK OF PENNSYLVANIA** (the "Secured Party"), as Agent for the Lenders under a certain Credit Agreement and Amended and Restated Credit Agreement, to **M&R MARKING SYSTEMS, INC.**, a Delaware corporation, (the "Debtor").

WHEREAS, the Debtor and the Secured Party are parties to a Collateral Assignment of Intellectual Property dated August 18, 1999 (the "Collateral Assignment"), and recorded in the United States Patent and Trademark Office on August 20, 1999 at Reel 010175, Frame 0551 under which the Debtor assigned to the Secured Party, in its capacity as Agent for the Lenders, all right, title and interest in and to certain patents and applications listed in Schedule I; and

WHEREAS, such Collateral Assignment was also recorded in the United States Patent and Trademark Office on August 22, 1999 at Reel 1947, Frame 0363 and clarified and re-recorded on January 31, 2005 at Reel 3018, Frame 0456, under which the Debtor granted to the Secured Party, in its capacity as Agent for the Lenders, a security interest in and to the trademarks listed in Schedule II; and

WHEREAS, the Debtor and the Secured Party are parties to an Amended Collateral Assignment and Security Agreement dated August 7, 2001 (the "Amended Collateral Assignment"), and recorded in the United States Patent and Trademark Office on September 17, 2004 at Reel 3051, Frame 0781, under which the Debtor granted to the Secured Party, in its capacity as Agent for the Lenders, a security interest in and to the trademarks listed in Schedule III; and


WHEREAS, in connection with a termination of the Credit Agreement and Amended and Restated Credit Agreement and the credit extended thereunder, the Secured Party and the Lenders are releasing the security interest in and granting to the Debtor all right, title and interest to such collateral under the Collateral Assignment and Amended Collateral Assignment.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged, the Secured Party hereby releases to Debtor all interest which the Secured Party and the Lenders possess or are otherwise entitled to in the patents and patent applications listed in Schedule I and the trademarks listed in Schedules II and III, together with all goodwill associated therewith, hereto by virtue of such Collateral Assignment and Amended Collateral Assignment.

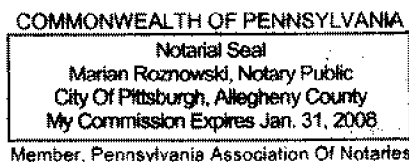
