RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTERESTS IN TRADEMARKS (this "Release") is made as of July 1, 2005 ("Effective Date") by Canadian Imperial Bank of Commerce, acting through its New York agency ("Assignee") in favor of National Electronics Warranty Corporation (the "Assignor").

WHEREAS, pursuant to the terms and conditions of that certain Trademark Security Agreement, dated as of August 17, 2004, (the "Trademark Security Agreement"), Assignor assigned and granted to Assignee a continuing security interest in all of its right, title and interest in and to its trademarks identified therein, including without limitation the trademark registrations and applications set forth on Schedule A hereto (collectively, the "Collateral") together with the goodwill associated therewith;

WHEREAS, Assignor has paid all of its outstanding indebtedness to Assignee secured by Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignee hereby terminates the Trademark Security Agreement, and hereby terminates, cancels, re-pledges, reassigns and releases any and all security interests it has against the Collateral.

If and to the extent Assignee has acquired any right, title or interest to any of the Collateral, it hereby assigns and transfers such rights, title or interest to Assignor.

Assignee shall take all further actions, and provide to Assignor and each of its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by Assignor, at Assignor's sole cost and expense, to more fully and effectively effectuate the purposes of this Release.
