TRADEMARK RELEASE

This Release granted on this 19th day of May, 2004, by Deutsche Bank Trust Company Americas (f.k.a. Bankers Trust Company), as Collateral Agent, with principal offices at 60 Wall Street, New York, New York 10005 (the "Assignee"), to Consolidated Container Company LLC, a Delaware corporation, with principal offices at 3101 Towercreek Parkway, Suite 300, Atlanta, Georgia 30339 (the "Assignor"), as follows:

WITNESSETH

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, the Assignee hereby releases, discharges, quit claims and relinquishes unto the Assignor any and all right, title and interest in and to the Marks, and more particularly, the security interest in (i) the trademarks, trademark registrations and trademark applications as set forth on Schedule A hereto, (ii) all Proceeds (as such term is defined in the Security Agreement referred to above) and products of the Marks, (iii) the goodwill of the businesses symbolized by the Marks and (iv) all causes of action arising prior to or after the date of the earliest assignment and grant hereunder for infringement of any of the Marks or unfair competition regarding the same, and granted to the Assignee by the Assignor by the Security

Agreement, which assignment was duly recorded on September 30, 1999 at Reel 1969, Frame 0918 in the United States Patent and Trademark Office.
