TRADEMARK SECURITY AGREEMENT TERMINATION AND RELEASE

THIS TRADEMARK SECURITY AGREEMENT TERMINATION AND RELEASE (this "Release") is made as of February 4, 2005 ("Effective Date") by Deutsche Bank Trust Company Americas, a New York banking organization (formerly known as Bankers Trust Company) ("Grantee"), in favor of Jet Plastica Industries, Inc., a Pennsylvania corporation ("Grantor").

WHEREAS, pursuant to the terms and conditions of that certain Security Agreement by and among Grantor, Jet Industries, Inc., JP Acquisition Corp., certain of its subsidiaries and Grantee dated June 20, 1997 (as amended, restated, supplemented or otherwise modified from time to time, the "Security Agreement"), Grantor assigned, transferred and conveyed to Grantee, and granted to Grantee, a security interest and mortgage in all of Grantor's right, title and interest in and to the trademark registrations listed in Schedule A hereto (collectively, the "Collateral");

WHEREAS, Grantee desires to terminate and release its security interest in the Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Grantee hereby covenants and agrees as follows:

1. Pursuant to Section 10.8(a) of the Security Agreement, Grantee hereby terminates and releases unto Grantor, its security interest in the Collateral, which security interest was recorded with the United States Patent and Trademark Office on July 14, 1997, at Reel 1614, Frame 0194.
