TRADEMARK ASSIGNMENT

This ASSIGNMENT (the "Assignment") is made effective as of the _____ day of February, 2005 by and between Kaval Wireless Technologies Inc., a Canadian Corporation ("Assignor"), and Powerwave Technologies, Inc., a Delaware Corporation, having its principal office or place of business at 1801 E. WHEREAS, Assignor is the record owner in the U.S. Patent and Trademark Office of the registered IN-HANCER and KAVAL marks and the intent-to-use trademark application for the "TAP-IN" mark, including all common law rights thereto (the "Trademark"), and the goodwill of the business symbolized thereby (together with the Trademark, the "Assigned Property");

WHEREAS, Assignor has effectively transferred to Assignee that portion of its existing and ongoing business to which the Assigned Property pertains;

WHEREAS, Assignor agrees to assign its entire right, title and interest in and to the Assigned Property to Assignee; and

WHEREAS, Assignee agrees to acquire Assignor's entire right, title and interest in and to the Assigned Property;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties hereby agree as follows:

1. The Assignor is the record owner of the registered IN-HANCER and KAVAL marks (U.S. trademark registration nos. 2,873,139 and 2,768,621, respectively) and the intent-to-use trademark application for the "TAP-IN" mark, filed on May 23, 2001, and identified by Serial Number 76/261,630, in the records of the United States Patent and Trademark Office.
2. Assignor is the sole and exclusive owner of the entire and unencumbered right, title and interest in and to the Trademark, free and clear of any liens, charges and encumbrances, including, without limitation, licenses and covenants by Assignor not to sue third persons, and Assignor hereby assigns to Assignee, its successors and assigns, its entire right, title and interest in and to the Assigned Property, and all rights and privileges pertaining to said Trademark in conformance with 15 U.S.C. §1060; 37 C.F.R. §3.16, together with the goodwill of the business symbolized by the mark, including all income, royalties, damages, and payments now or hereafter due or receivable in respect of the Assigned Property, and all causes of action (either in law or equity) and the right to sue, counterclaim, and recover for past, present, and future infringements, misappropriations, or dilutions of the rights assigned to Assignee hereunder, and all rights corresponding thereto throughout the world.

3. The registered IN-HANCER and KAVAL marks and the intent-to-use trademark application for the "TAP-IN" mark are subsisting and have not been adjudged invalid or unenforceable, in whole or in part.

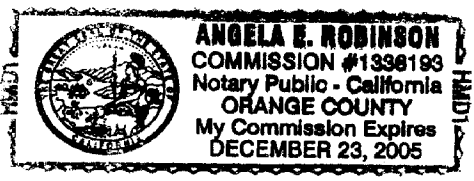
