TRADEMARK ASSIGNMENT AND RELEASE OF SECURITY INTEREST

This Assignment and Release of Security Interest, made this 10 day of October, 1995 by and between General Electric Capital Corporation, a New York Corporation ("General Electric") and The Pfaltzgraff Co., a Pennsylvania Corporation ("Pfaltzgraff") (hereinafter the "Assignment").

WHEREAS, Pfaltzgraff is the beneficial owner of certain trademarks, trade names, terms, designs and applications therefor described in a Trademark Collateral Assignment and Security Agreement dated as of the 28th day of May, 1993 (hereinafter the "Security Agreement"), as annexed hereto and made a part hereof;

WHEREAS, the parties hereto (together with other subsidiaries of Pfaltzgraff which are not necessary parties hereto) executed the Security Agreement by which Pfaltzgraff (and certain other subsidiaries of Pfaltzgraff) made a collateral assignment and granted a security interest in certain trademarks, trade names, trade styles and service marks including trademarks, trade names, trade styles and service marks as described in Exhibit I hereto of Syracuse China Corporation (hereinafter the "Syracuse Marks"); and

WHEREAS, the Syracuse Marks were assigned to Pfaltzgraff as of May 5, 1993; and

WHEREAS, Pfaltzgraff contemporaneously herewith is entering into an asset purchase agreement (the "Asset Purchase Agreement") under which, *inter alia*, the Syracuse Marks will be conveyed to LG Acquisition Corp.; and

WHEREAS, in order to facilitate the transfer of assets pursuant to the Asset Purchase Agreement, General Electric is willing to consent to the release of its security interest in the Syracuse Marks and reassigns the Syracuse Marks to Pfaltzgraff.

NOW, THEREFORE, in consideration of the premises and other such valuable consideration, the receipt and sufficiency of which are hereby acknowledged, General Electric hereby agrees as follows:

1. COLLATERAL ASSIGNMENT AND RELEASE OF SECURITY INTEREST.

General Electric hereby releases Pfaltzgraff from the continuing security interest and general lien upon the Syracuse Marks described in Exhibit I as annexed hereto and made apart hereof and assigns, conveys and transfers to Pfaltzgraff:

A. All of General Electric's now existing or hereafter acquired right, title and interest in and to:

- i. The Syracuse Marks; and
- ii. All prints and labels on which the Syracuse Marks appear, have appeared or will appear, and all designs and general intangibles of any nature relating to said Syracuse Marks; and
- iii. All applications, registrations and recordings relating to the Syracuse Marks in the United States Patent and Trademark office or in any similar office or agency of the United States or any State thereof, any political subdivision thereof or in any other country, and all renewals thereof.

B. The goodwill of the business symbolized by each of the Syracuse Marks, including, without limitation, all customer list and other records relating to the distribution of products and services bearing the Syracuse Marks; and

C. Any and all proceeds of any of the foregoing, including, without limitation, any claims by General Electric against third parties for infringement of the trademarks or any licenses with respect thereto.

2. LIMITATION OF RELEASE.

This release of collateral assignment and security interest shall only apply to the collateral (as that term is defined in the Security Agreement) referred to herein as the Syracuse Marks as described in Exhibit I hereto.

3. FURTHER ASSURANCES.

General Electric will render such assistance and provide such further assurances as required to affectively release the Syracuse Marks from the security interests recorded in the United States Patent And Trademark Office and to assign the Syracuse Marks to Pfaltzgraff including the execution of such additional documents and assignments as may be required.

4. COSTS.

The costs of recording such releases shall be the sole responsibility of Pfaltzgraff.
