WHEREAS, U.S. PLASTIC IP LUMBER CORPORATION, a Delaware corporation having its principal place of business at 2711 Centerville Road, Suite 400 Wilmington, Delaware, 19808 (together with its successors and assigns from and after the date hereof, "Assignor"), is the owner of the entire right, title and interest in, to and under the mark CLEAN EARTH (hereinafter "the Trademark"), together with U.S. Registration No. 1,740,437, being the registration of such mark with the U.S. Patent and Trademark Office (hereinafter "the Trademark Registration"), and together with the goodwill of the business in connection with which the Trademark is associated and which is symbolized by the Trademark (hereinafter the "Goodwill"), along with the right to sue and recover for any past or future infringements thereof (hereinafter the "Additional Rights"); and

WHEREAS, CLEAN EARTH, INC., a Delaware corporation having its principal place of business at 1000 Crawford Place, Suite 300, Mt. Laurel, NJ (together with its successors and assigns from and after the date hereof, "Assignee"), is a wholly owned subsidiary of U.S. Plastic Lumber Corp., the indirect parent of Assignor, and is desirous of acquiring the entire right, title and interest in, to and under the Trademark, together with the Trademark Registration, and together with the Goodwill, along with the Additional Rights;

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, Assignor does hereby sell and assign unto Assignee forever the entire right, title and interest in, to and under the Trademark, together with the Trademark Registration, and together with the Goodwill, along with the Additional Rights (all of which right, title and interest Assignor hereby represents and warrants to Assignee is held by Assignor immediately before the giving effect to this sale and assignment), to be held and enjoyed by Assignee for its own use and benefit.

Assignor hereby agrees to execute and deliver, at the request of Assignee, all papers, instruments and assignments, and to perform any other reasonable acts Assignee may request from time to time in order to better vest the entire right, title and interest in, to and under the Trademark and the Trademark Registration in Assignee forever, and/or to provide evidence to support any of the foregoing in the event such evidence is deemed necessary by Assignee, in its sole discretion, to the extent such evidence is in the possession or control of Assignor.
