RELEASE OF SECURITY INTEREST

(TRADEMARKS)

WHEREAS, Williams Scotsman, Inc., a Maryland corporation (herein referred to as "Williams Scotsman"), owns certain of the trademarks listed on the annexed Schedule 1 annexed hereto as part hereof, which trademarks are registered in the United States Patent and Trademark Office ("USPTO") (the "Williams Scotsman Trademarks");

WHEREAS, Space Master International, Inc., a Georgia corporation (herein referred to as "Space Master"), owns certain of the trademarks listed on the annexed Schedule 2 annexed hereto as part hereof, which trademarks are registered in the USPTO (the "Space Master Trademarks");

WHEREAS, Williams Scotsman and Space Master are individually referred to herein each as a "Trademark Owner" and collectively as the "Trademark Owners", and the Williams Scotsman Trademarks and the Space Master Trademarks are referred to collectively herein as the "Trademarks";

WHEREAS, the Trademark Owners were obligated to Deutsche Bank Trust Company Americas (a successor in interest to Bankers Trust Company), as collateral agent (referred to herein as the "Collateral Agent") and the other Secured Parties as defined in the U.S. Security Agreement dated as of March 26, 2002 (the "Original Security Agreement") among the Trademark Owners, the other parties named therein and the Collateral Agent for the payment and performance of the Obligations (as defined in the Original Security Agreement);

WHEREAS, the Trademark Owners were obligated to the Collateral Agent and the other Secured Parties as defined in the Amended and Restated U.S. Security Agreement U.S. Security Agreement dated as of August 18, 2003 (the "Amended and Restated Security Agreement") among the Trademark Owners, the other parties named therein and the Collateral Agent for the payment and performance of the Obligations (as defined in the Amended and Restated Security Agreement);

WHEREAS, pursuant to the Original Security Agreement, and the Grant of Security Interest in United States Trademarks dated as of March 26, 2002, which was recorded in the USPTO as of May 10, 2002 at Reel 2506, Frame 0128 with respect to the Williams Scotsman Trademarks and at Reel 2507, Frame 0106 with respect to the Space Master Trademarks, the Trademark Owners granted to the Collateral Agent a security interest in, and mortgage on, all right, title and interest of the Trademark Owners in and to the Trademarks, together with the goodwill of the business symbolized by the Trademarks and the applications and registrations thereof, and all proceeds thereof, including, without limitation, any and all causes of action

which may exist by reason of infringement thereof (the "Original Collateral"), to secure the payment, performance and observance of the Obligations;

WHEREAS, pursuant to the Amended and Restated Security Agreement and the Amended and Restated Grant of Security Interest in United States Patents dated as of August 18, 2003, which was recorded in the USPTO at as of September 17, 2003 at Reel 2835, Frame 0485 with respect to the Williams Scotsman Trademarks and as of September 17, 2003 at Reel 2831 , Frame 0165, and as of October 14, 2003 at Reel 2846, Frame 0605, with respect to the Space Master Trademarks, the Trademark Owners granted to the Collateral Agent a security interest in, and mortgage on, all right, title and interest of the Trademark Owners in and to the Trademarks, together with the goodwill of the business symbolized by the Trademarks and the applications and registrations thereof, and all proceeds thereof, including, without limitation, any and all causes of action which may exist by reason of infringement thereof (the "Amended and Restated Collateral", and together with the Original Collateral, the "Collateral"), to secure the payment, performance and observance of the Obligations;

WHEREAS, the USPTO records incorrectly show an additional grant of security interest by Space Master in the Williams Scotsman Trademarks recorded in the USPTO as of February 17, 2004 at Reel 2917, Frame 0161;

WHEREAS, the USPTO records incorrectly show additional grants of a security interest by Williams Scotsman in the Space Master Trademarks recorded in the USPTO as of September 17, 2003 at Reel 2917, Frame 0669 and as of October 14, 2003 at Reel 2846, Frame 0605;


