

RELEASE OF SECURITY INTEREST

Reference is made to the Indenture dated as of November 30, 2004 (the "Indenture") among MLA Multibrand Holdings, Inc., a Delaware corporation (the "Company"), IPIFS Guarantee Corp., a Delaware corporation, and Wilmington Trust Company, a Delaware banking corporation, as Trustee (the "Trustee"), under which the Company's Royalty-Backed Notes were issued. RELEASE OF SECURITY INTEREST IN
INTELLECTUAL PROPERTY COLLATERAL

WHEREAS, the Grantor has requested that Wilmington release its security interest in its patents, trademarks, copyrights, and other intellectual or industrial property, whether registered or not and whether under license or otherwise, as defined in the Grants of Security Interest in connection with the termination of the Indenture (the "Released Collateral").


