TERMINATION OF SECURITY INTERESTS IN TRADEMARKS AND PATENTS

Each such Security Agreement was subsequently recorded with the United States Patent and Trademark Office.

2. U.S. Bank now desires to terminate its security interests in the Trademark and Patent Collateral.


