

**TRADEMARK RELEASE OF SECURITY INTEREST**

This Release granted on this 10th day of June, 2005, by Deutsche Bank Trust Company Americas (formerly known as Bankers Trust Company), as Collateral Agent ("Agent"), to Grove U.S. L.L.C., a Delaware limited liability company with principal offices at 1565 Buchanan Trail East, Shady Grove, Pennsylvania 17256 ("Grantor"), as follows:
