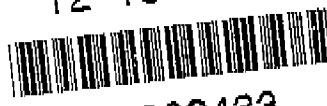

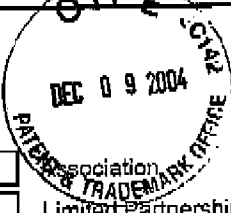

**ASSIGNMENT OF INTELLECTUAL PROPERTY (U.S.)**

THIS ASSIGNMENT OF INTELLECTUAL PROPERTY (the "Agreement") is made and entered into as of November 1, 2004 (the "Effective Date"), by and among Tango Acquisition, Inc., a Delaware corporation ("TAI") and Tango License Corporation, a Delaware corporation ("TLC"). Each of TAI and TLC are wholly-owned subsidiaries of Dave & Buster's, Inc., a Missouri corporation ("D&B").

**WITNESSETH:**

WHEREAS, TAI (hereinafter the "Assignor") was a party to that certain Asset Purchase Agreement dated September 24, 2004 (the "Purchase Agreement"), by and among TAI, D&B, Jillian's Entertainment Corporation, a Florida corporation ("JEC"), and certain other subsidiaries of JEC; and

WHEREAS, for the convenience of consummating the closing of the Purchase Agreement, Assignor has executed an Assignment of Intellectual Property (U.S.); and

WHEREAS, Assignor desires to reflect that such Transferred Intellectual Property shall be immediately vested in TLC (hereinafter the "Assignee").

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, it is hereby agreed as follows:

1. Assignor hereby assigns to Assignee all of the rights, title and interest in and to the Transferred Intellectual Property as it relates to the United States
2. Assignor and Assignee agree to execute and deliver such further instruments, agreements and assurances, as may be reasonably requested by the other, to evidence and provide for the assignment by Assignor and the acceptance and assumption by Assignee of the Transferred Intellectual Property as set forth herein.
3. This Assignment shall not be deemed to supersede any of the provisions of the Purchase Agreement, and if there is any conflict between the terms of this Agreement and the Purchase Agreement, the terms of the Purchase Agreement, as applicable, will prevail.
4. Except as specifically defined herein, all capitalized terms shall have the meaning set forth in the Purchase Agreement.
