**CONFIRMATION OF SECURITY INTEREST
IN INTELLECTUAL PROPERTY**

WHEREAS:

Kenna Group LP (the “Debtor”), a limited partnership formed under the laws of Ontario with offices at 1000-90 Burnhamthorpe Road West, Mississauga, Ontario, L5B 3C3, is the owner of the trade-marks set forth in Exhibit A hereto, the registrations and applications for the trade-marks identified therein and the underlying goodwill associated with such trade-marks (collectively, the “Trade-Marks”); and

Royal Bank of Canada, as agent for certain lenders (the “Collateral Agent”), with offices at Royal Bank Plaza, 4th Floor, South Tower, 200 Bay Street, Toronto, Ontario, M5J 2W7, has entered into an agreement with the Debtor, as reflected by a separate document entitled the “Security Agreement” dated as of the 14th day of September which the Debtor granted to the Collateral Agent, a security interest in certain property, including the Trade-Marks, in consideration of the provision of certain credit facilities to Newport Partners Holdings LP of which the Debtor is or will be, directly or indirectly, associated;

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are acknowledged and in accordance with the terms and obligations set forth in the Security Agreement, the Debtor confirms the grant to the Collateral Agent of a security interest in and to the Trade-Marks.
