Assignor hereby authorizes the Patent and Trademark Offices of the United States, the United Kingdom and Australia to record the transfer of the Marks to Assignee as assignee of Assignor's entire right, title and interest therein, and to issue to Assignee any registration which may issue with respect to the Marks, in accordance with this Trademark Assignment.
