RELEASE OF SECURITY INTERESTS IN TRADEMARKS


This Release of Security Interests in Trademarks is granted and conveyed as of September 23, 2005 by BHC Interim Funding II, L.P. ("BHC"), in favor of VeriClaim, Inc. ("VeriClaim") and T & H Holdings, Inc. ("T & H Holdings", and together with VeriClaim, the "Borrowers").

WHEREAS, BHC and the Borrowers entered into a Loan and Security Agreement dated as of October 19, 2004 (the "Loan and Security Agreement" and together with any other intellectual property security agreements between BHC and the Borrowers in respect of the Marks referred to below, the "Security Agreements"), under which the Borrowers granted to BHC a security interest in the trademarks listed on the attached Schedule A, any applications for federal registration or federal registrations therefor, and the goodwill associated therewith (the "Marks").

WHEREAS, the United States Patent and Trademark Office ("PTO") recorded the Security Agreements against the Marks on October 29, 2004 at Trademark Reel 3073, Frame 0088.

WHEREAS, the Borrowers have satisfied all of their outstanding obligations under the Security Agreements, and the parties seek to make a record of BHC's release and reassignment to the Borrowers of any and all of its security interest in the Marks.

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which the parties acknowledge, BHC hereby (1) releases, discharges and relinquishes, as of September 23, 2005 its security interests in the Marks, and (2) reassigns to the Borrowers, as of September 23, 2005, all right title, and interest that it may have had in the Marks, including the goodwill associated with the Marks, any and all applications or registrations therefor, and the right to sue for past, present and future infringements, and the proceeds thereof, including, without limitation, license royalties and proceeds of infringement suits. BHC specifically acknowledges that the Security Agreements are no longer effective, and that it does not own any rights to or have any ownership interest in the Marks, and all of the rights and remedies with respect to the Marks have been and are hereby extinguished.
