The undersigned officers hereby certify that:

1. They are, respectively, Senior Executive Vice President and Assistant Secretary of Foothill Capital Corporation, a California corporation (the "Corporation").

2. Article First of the Articles of Incorporation of this Corporation is amended in its entirety to read as follows:

"FIRST: The name of the corporation is Wells Fargo Foothill, Inc."

3. The above amendment to the Articles of Incorporation has been duly approved by the Board of Directors of the Corporation.

4. The above amendment to the Articles of Incorporation has been duly approved by the required vote of the sole shareholder of the Corporation in accordance with Section 902 of the California Corporations Code. The number of issued and outstanding shares entitled to vote with respect to the amendment is 1,575,000 shares of common stock, the sole outstanding class of stock of the Corporation. All (100%) of the outstanding shares of the common stock of the Corporation voted in favor of the above amendment, which number of shares equaled or exceeded the vote required. The percentage vote required was more than 50%.

The undersigned further declare under penalty of perjury under the laws of the State of California that the matters set forth in this Certificate of Amendment are true and correct of our own knowledge.
