
**CONFIRMATORY TRADEMARK ASSIGNMENT**

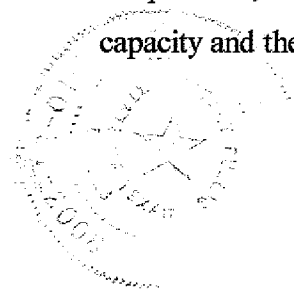
