

RELEASE OF SECURITY AGREEMENT

THIS RELEASE dated as of **June 15, 2005** (this "<u>Release</u>") is made by U.S.

Bank National Association, a National Association, acting in its capacity as secured party (in such capacity, the "<u>Secured Party</u>") under that certain Security Agreement, dated as of **December 18, 2003** and recorded in the records of the United States Patent and Trademark Office (as amended, supplemented or modified and in effect from time to time, the "<u>Security Agreement</u>"), among **Airtite, Inc**, (the "<u>Debtor</u>") and the Secured Party;

WITNESSETH:
