TERMINATION OF ASSIGNMENT

WHEREAS, TYCO INDUSTRIES, INC., (the "Debtor") and the undersigned (the "Lenders") are parties to a Security Agreement - Trademarks dated November 16, 1988 (the "Agreement") and an Assignment for Security dated November 16, 1988 (the "Assignment");

WHEREAS, the Lenders desire to release their interest in the Collateral and to terminate the Assignment in respect of the Collateral;

NOW, THEREFORE, the Lenders do hereby (1) release any and all right, title and interest in the Collateral granted to the Lender pursuant to the Agreement and the Assignment, and (2) consent to the termination and discharge of record of the Assignment as respects the Collateral.
