**TERMINATION OF SECURITY AGREEMENT**

**(TRADEMARKS)**

WHEREAS, Poof-Slinky, Inc., a Michigan corporation, with an address at 45400 Helm Street, Plymouth, Michigan 48170 (herein referred to as "Assignor"), and successor-in-interest to Poof Products, Inc., owns trademark registrations and applications pending in the United States Patent and Trademark Office (hereinafter the "Trademarks" attached as Exhibit A);

WHEREAS, Assignor had pledged the Trademarks as security for a credit agreement (the "Security Agreement") to Comerica Bank, a Michigan banking corporation, as agent for the lenders (herein referred to as "Assignee") and granted to Assignee a security interest in all right, title and interest of Assignor in and to the Trademarks (the "Collateral") to secure the prompt payment, performance and observance of certain obligations of Assignor to Assignee (the "Obligations");

WHEREAS, the Obligations have been discharged; and

WHEREAS, Assignee desires to terminate the Security Agreement;

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, Assignee does hereby terminate the Security Agreement dated July 28, 2003, recorded in the U.S. Patent and Trademark Office on March 24, 2004, at reel 2816, frame 0052, and hereby terminates, cancels and releases any and all security interests in and to the Trademarks.

Assignee does hereby agree to take all further actions, and to execute and deliver, and to provide Assignor, its successors, assigns or other legal representatives, any and all such documents or other instruments, reasonably requested by Assignor to more fully and effectively effectuate the purposes of this termination.
