**ASSIGNMENT OF UNITED STATES TRADEMARKS,**

**TRADEMARK REGISTRATIONS AND APPLICATIONS FOR REGISTRATION**

In connection with the foregoing, the Assignor hereby acknowledges and agrees to

execute any and all transfer notices and other documents necessary and to do all other acts necessary or advisable in order to validly and effectively sell, assign and transfer said Trademarks, Trademark Registrations and Applications for Registration unto Assignee.

The foregoing sale, assignment and Transfer shall include all claims for profits and damages of past infringement, if any, of said Trademarks, Trademark Registrations and Applications for, with the right to sue for and collect the same for the Assignee's own use and advantage and for the use and advantage of its successors, assigns or other legal representatives.

This Assignment is being executed in connection with the closing of the Purchase Agreement.
