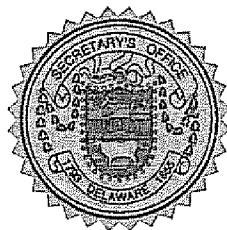

OF CERTIFICATE OF INCORPORATION

The corporation organized and existing under and by virtue of the General Corporation Law of the State of Delaware does hereby certify:

**FIRST:** That pursuant to Action of the Unanimous Written Consent of each of the Sole Shareholder and of the Board of Directors of Sweetheart Cup Company Inc. resolutions were duly adopted setting forth a proposed amendment of the Amended and Restated Certificate of Incorporation of said corporation, declaring said amendment to be advisable. The resolution setting forth the proposed amendment is as follows:

NOW THEREFORE BE IT RESOLVED, that the First Article of the Amended and Restated Certificate of Incorporation of the Corporation be amended as follows:

"FIRST: The name of the Corporation is "Solo Cup Operating Corporation."

FURTHER RESOLVED, that the Second Article of the Amended and Restated Certificate of Incorporation shall be amended as follows:
