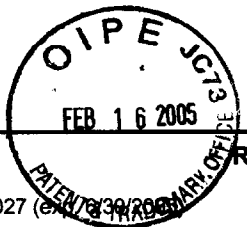

**ASSIGNMENT OF TRADEMARK
COLLATERAL SECURITY AND PLEDGE AGREEMENT**

This Assignment of Trademark Collateral Security and Pledge Agreement ("Assignment") is executed as of January 21, 2005, by Deutsche Bank Trust Company Americas, a New York banking corporation ("Deutsche Bank"), in its capacity as Collateral Agent ("Assignor"), in favor of Republic Financial Corporation, a Colorado corporation ("RFC"), in its capacity as successor Collateral Agent ("Assignee").

Assignor hereby assigns, quitclaims and conveys to Assignee all of Assignor's right, title and interest in, to, and under that Trademark Collateral Security and Pledge Agreement dated as of March 21, 2003, executed by American Identity Inc., a Delaware corporation, in favor of Assignor and recorded at Reel 2174/0101, United States Patent and Trademark Office (the "Trademark Security Agreement"). The Trademark Security Agreement conveyed to Assignor certain rights with respect to the trademarks described in Schedule A attached hereto, together with the goodwill associated therewith and all registrations, recordings and renewals thereof, and all applications in connection therewith, issued by or filed in a national, state or local governmental authority of any country.


