**TERMINATION AND RELEASE OF SECURITY INTEREST  
IN TRADEMARKS**

This Termination and Release of Security Interest in Trademarks (this "Release") is made and executed this 28<sup>th</sup> day of November 2005, by The CIT Group/Commercial Services, Inc. ("CIT") in favor of Under Armour, Inc. (f/k/a KP Sports, Inc.) (the "Borrower"), as follows:

W I T N E S S E T H

WHEREAS, the Borrower and CIT entered into that certain Accounts Receivable Financing Agreement, dated as of June 21, 2001 (as amended and/or supplemented from time to time, the "Financing Agreement");

WHEREAS, in connection with the Financing Agreement, the Borrower and CIT entered into a certain Security Agreement-Intellectual Property, dated as of September 28, 2001 (as amended and/or supplemented from time to time, the "Intellectual Property Security Agreement") which was recorded with the U.S. Patent and Trademark Office on January 15, 2002 at Reel 002431, Frame 0135, et seq.;

WHEREAS, pursuant to the Financing Agreement and Intellectual Property Security Agreement, the Borrower granted CIT liens in, and security interests upon, all of the Borrower's right, title, and interest in, to and under, among other collateral, the Trademarks (as defined in the Intellectual Property Security Agreement), including, without limitation, the trademarks set forth on Exhibit A attached hereto and made an integral part hereof; and

WHEREAS, CIT has agreed to release and terminate its liens in, and security interests upon, all of the Trademarks;

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby expressly acknowledged, CIT hereby unconditionally, irrevocably and absolutely releases, discharges and terminates its liens in, and security interests upon, the


Trademarks, and reassigns to the Borrower all of CIT's right, title and interest in the Trademarks and the goodwill associated therewith, in each case including, without limitation, the trademarks listed on Exhibit A attached hereto and made an integral part hereof.

This Trademark Release shall be binding upon CIT and its successors and assigns.

CIT hereby authorizes and requests the Director of Patents and Trademarks of the United States of America to record this Release against the Trademarks.
