## AMENDMENT TO INTELLECTUAL PROPERTY SECURITY AGREEMENTS

This Amendment to Intellectual Property Security Agreements (this "Agreement") is made this 23rd day of November, by and among Cybertrust Holdings., a Delaware corporation (the "Parent"), Cybertrust, Inc., a Delaware corporation ("Borrower") and Comerica Bank ("Bank").

### RECITALS

WHEREAS, pursuant to the terms of an Intellectual Property Security Agreement, dated June 24, 2005 (the "Borrower IP Security Agreement"), by and between Borrower and the Bank, Borrower granted to Bank a security interest in certain of Borrower's intellectual property;

WHEREAS, pursuant to the terms of an Intellectual Property Security Agreement, dated June 24, 2005 (the "Parent IP Security Agreement"), by and between Parent and the Bank, Parent granted to Bank a security interest in certain of Parent's intellectual property (the Borrower IP Security Agreement and the Parent IP Security Agreement are collectively referred to herein as the "IP Security Agreements"); and

WHEREAS, the Bank has agreed to release its security interest in a certain asset described on Exhibit C to each of the IP Security Agreements as further described herein.


NOW, THEREFORE, the undersigned parties, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties hereto agree as follows:

1. Amendment of Intellectual Property Security Agreements. Each of the Borrower, Parent and Bank hereby acknowledge and agree that each of the IP Security Agreements shall be amended to remove all reference to the registered trademark INTELLISHIELD (registration number 2806470, registration date January 1, 2004) (the "Trademark") from Exhibit C to both such agreements. By signing below, the Bank hereby acknowledges and agrees that it has released its security interest in the Trademark.
2. Effect of Amendments. Except for the amendments of the IP Security Agreements pursuant to Section 1 above, all of the terms and conditions of the IP Security Agreements remain unmodified and in full force and effect.
3. Execution in Counterparts. This Agreement may be executed in counterparts, which together shall constitute one and the same instrument.


