**TRADEMARK RELEASE AND REASSIGNMENT**

THIS TRADEMARK RELEASE AND REASSIGNMENT is made as of December 14, 2005, by **NEXBANK, SSB**, a Texas Chartered Savings Bank and successor in interest to Heritage Bank, SSB (“**Bank**”).

W I T N E S S E T H:

WHEREAS, Bank and COMSYS Services LLC, a Delaware limited liability company and successor by merger to Venturi Technology Partners, LLC, a Delaware limited liability company (“**Grantor**”), were parties to that certain Trademark Security Agreement dated as of September 30, 2004 (the “**Assignment**”), pursuant to which Grantor granted a security interest to Bank in certain trademarks (the “**Trademarks**”) and Trademark Rights (as defined below) as security for certain obligations owing by Grantor to Bank, including the Trademarks set forth on Schedule 1 hereto; and

WHEREAS, the Assignment was recorded by the Trademark Division of the United States Patent and Trademark Office on October 13, 2004, at Reel 002954, Frame 0576; and

WHEREAS, Grantor has requested that Bank release its security interest in the Trademarks and Trademark Rights and reassign the same to Grantor.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Bank hereby releases its security interest in all of Grantor’s right, title and interest in and to the following (collectively the “**Trademark Rights**”):

(i) each Trademark and application for Trademark listed on Schedule I annexed hereto, together with any reissues, continuations or extensions thereof; and


(ii) all products and proceeds of the foregoing, including without limitation, any claim by Grantor against third parties for past, present or future infringement of any Trademark.

2. Bank hereby reassigns, grants and conveys to Grantor, without any representation, recourse or undertaking by Bank, all of Bank's right, title and interest in and to the Trademarks and the Trademark Rights.
