AMENDMENT NUMBER ONE TO INTELLECTUAL PROPERTY AGREEMENT

This Amendment (the "Amendment") is entered into as of the 30-day of April, 1999, by and between UNION OIL COMPANY OF CALIFORNIA, a California corporation ("Union"), and TOSCO CORPORATION, a Nevada corporation ("Tosco"), and constitutes an amendment to that certain Intellectual Property Agreement (the "Intellectual Property Agreement"), dated as of March 31, 1997, by and between Union and Tosco. Capitalized terms used herein and not defined herein shall have the meanings ascribed to them in the Intellectual Property Agreement, as amended hereby.

WITNESSETH

WHEREAS, pursuant to the terms of the Intellectual Property Agreement, Union assigned to Tosco certain trademarks and service marks, as set forth in Schedule I.A to the Intellectual Property Agreement (the "Assigned Marks");

WHEREAS, certain of the Assigned Marks were previously assigned by Union to National Auto/Truckstops, Inc. (the "Road King Marks"); and

WHEREAS, the parties at this time desire to amend the Intellectual Property Agreement, in accordance with the amendment provisions of Section 11.6, to exclude the Road King Marks from Schedule I.A of the Intellectual Property Agreement;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and intending to be legally bound hereby, the parties agree to amend the Intellectual Property Agreement, effective immediately, as follows:

1. Amendment to Schedule I.A. Schedule I.A to the Intellectual Property Agreement is amended by deleting any and all reference to the following:

- King of the Road (Design) (Registration No. 1379114)
- Road King (Registration No. 781013)
- Road King Drivers' Club (Registration No. 1369595)

2. Construction. This Amendment shall be governed by and construed in accordance with the laws of the State of California.

3. Entire Amendment. This Amendment constitutes the entire agreement among the parties pertaining to the subject matter hereof and supercedes any and all prior or contemporaneous amendments relating to the subject matter hereof. Except as expressly amended hereby, the Intellectual Property Agreement shall remain unchanged and in full force and effect. This Amendment shall be deemed part of and is hereby incorporated into the Intellectual Property Agreement.

4. Counterparts. This Amendment may be executed in any number of counterparts, all of which taken together shall constitute one and the same instrument and any of the parties hereto may execute this Amendment by signing any such counterpart. Delivery of an executed counterpart of this Amendment by telefacsimile shall be equally as effective as delivery of an original executed counterpart of this Amendment. Any party delivering an executed counterpart of this Amendment by telefacsimile also shall deliver an original executed counterpart of this Amendment, but the failure to deliver an original executed counterpart shall not affect the validity, enforceability, and binding effect of this Amendment.

5. Amendments. This Amendment cannot be altered, amended, changed or modified in any respect or particular except by an instrument in writing signed by the party against whom enforcement is sought.
