THIS ASSIGNMENT is made on 18 August 2003

BETWEEN:

- (1) **ASSOCIATED HEALTH FOODS LIMITED** (No. 654806) whose registered office is at Aire Valley Business Centre, Lawkholme Lane, Keighley, West Yorkshire, BD21 3BB (the "Assignor");
- (2) **PETER BLACK HEALTHCARE LIMITED** (No. 931141) whose registered office is at Aire Valley Business Centre, Lawkholme Lane, Keighley, West Yorkshire, BD21 3BB ("PBHC");
- (3) **PETER BLACK DIRECT MARKETING LIMITED** (No. 04500877) whose registered office is at Aire Valley Business Centre, Lawkholme Lane, Keighley, West Yorkshire, BD21 3BB ("PBDM"); and
- (4) **MERCK KGaA** a company registered in Germany, whose registered office is at Frankfurter Str. 250, 64293, Darmstadt, Germany (the "Assignee").

RECITALS

- (A) The Assignor is the registered proprietor and beneficial owner of the registered trade marks (the "Trade Marks") and the trade mark applications (the "Applications") as set out in schedules 1, 2 and 3 of this agreement.
- (B) Under an option agreement dated 23 August 2002 (the "Option Agreement") and made between PBHC (1) and the Assignor (2), the Assignor granted PBHC the right to call on the Assignor to assign to PBHC the Trade Marks and the Applications, together with the goodwill of the business of the Assignor relating to the goods in respect of which the Trade Marks and the Applications are registered (the "Associated Goodwill"), the Intellectual Property as defined in Option Agreement (the "Intellectual Property") and the Exclusive Know-How as defined in the Option Agreement (the "Exclusive Know-How").
- (C) Pursuant to a hive-up agreement dated 23 August 2002 (the "Hive-up Agreement") and made between PBHC (1) and Busy Romantic Limited (2) and a subsequent transfer agreement dated 31 August 2002 (the "Transfer Agreement") and made between Busy Romantic Limited (in liquidation) (1), Timothy Gerard Walsh and Richard Victor Yerburgh Setchim (as joint liquidators of Busy Romantic Limited) (2) and PBDM (3), the benefit of the Option Agreement was assigned to PBDM.
- (D) PBDM wishes to exercise the right contained in the Option Agreement, subject to the variation to such agreement agreed pursuant to clause 2, and the Assignor has agreed to assign the Trade Marks and the Applications, the Associated Goodwill, Intellectual Property and the Exclusive Know-how on the terms set out in this agreement.

THE PARTIES AGREE AS FOLLOWS:

1. DEFINITIONS AND INTERPRETATION

In this agreement the following words and expressions and abbreviations have the following meanings, unless the context otherwise requires:

"**Encumbrance**" means any mortgage, charge (fixed or floating), pledge, lien, hypothecation, trust, right of set-off, licence, option or other third party right or interest (legal or equitable) including any right of pre-emption, assignment by way of security, reservation of title or any other security interest of any kind howsoever created or arising or any other agreement or arrangement (including a sale and repurchase arrangement) having similar effect.

2. VARIATION

In consideration of the payment of £1.00 paid by PBDM to each of the Assignor and PBHC, the Assignor, PBHC and PBDM agree the following variations to the Option Agreement:

(a) Clause 3.1 shall be deleted in its entirety and replaced with the following:

"In consideration of the payment of £1.00 (receipt of which is hereby acknowledged) at any time during the term of this Agreement PBHC shall have the right on delivery of notice to require the transfer of the Assets from the Company to PBHC or its nominee".

(b) Part B of schedule 1 shall be amended to include the Trade Marks identified in schedule 2 of this agreement.

(c) Part A of schedule 1 shall be amended to include the Applications identified in schedule 3 of this agreement.

3. ASSIGNMENT

In pursuance of the Option Agreement the Assignor does **HEREBY ASSIGN** and transfer with full title guarantee and free of Encumbrances all right, title and interest in the Trade Marks, the Applications, Associated Goodwill, the Intellectual Property and the Exclusive Know-How including all statutory and common law rights attaching to the foregoing and the right to sue for past infringements thereof and to retain any damages obtained as a result of such action, to the Assignee.

4. ASSIGNOR'S OBLIGATIONS

4.1 The Assignor shall at the expense of the Assignee do and execute or procure that there shall be done and executed all such documents, deeds, matters, acts and things as the Assignee may at any time reasonably require properly to vest the Trade Marks, the Applications, the Intellectual Property, the Associated Goodwill and the Exclusive Know-how in the Assignee or otherwise to perfect the Assignee's title thereto.

4.2 The Assignor shall disclose to the Assignee all information necessary to effect the transfer of the Exclusive Know-How and to provide the Assignee with access to and copies of all such information in any form whatsoever.

5. **GOVERNING LAW AND JURISDICTION**

5.1 This agreement (and any dispute, controversy, proceedings or claim of whatever nature arising out of or in any way relating to this agreement or its formation) shall be governed by and construed in accordance with English law.

5.2 Each party to this agreement irrevocably agrees that the courts of England shall have exclusive jurisdiction to hear and decide any suit, action or proceedings and/or to settle any disputes which may arise out of or in connection with this agreement and, for these purposes, each party irrevocably submits to the jurisdiction of the courts of England.

6. **COUNTERPARTS**

This agreement and any of the documents referred to in it may be executed in any number of counterparts which shall together constitute one agreement. Any party may enter into this agreement by executing a counterpart and this agreement shall not take effect until it has been executed by all parties.

IN WITNESS whereof this agreement has been executed as a deed on the date first above written.


