Release of Lien on Trademarks

This Release of Lien on Trademarks (the "Release"), dated as of April 29, 2005, is made by Bank of America, N.A., a National Association, as administrative agent (in such capacity, "Bank"), in favor of Foamex L.P., a Delaware limited partnership ("Grantor").

WHEREAS, Grantor entered into a Trademark Security Agreement, dated as of August 18, 2003 and recorded in the United States Patent and Trademark Office as of August 22, 2003 at Reel 2806, Frames 0867-0891, pursuant to which Grantor granted to the Bank a security interest in and lien on all right, title and interest of the Grantor in certain trademarks, including the trademark registrations and applications set forth on Schedule A attached hereto and the unregistered trademarks set forth on Schedule B attached hereto (the trademarks and applications set forth on such Schedules A and B, the "Released Trademarks") and in the goodwill of the business symbolized thereby and other rights connected with the use of the Released Trademarks to secure the performance of certain obligations;

WHEREAS, in accordance with Section 7.11(xv) of that certain Credit Agreement, dated as of August 18, 2003 (as amended, modified or otherwise supplemented to the date hereof, the "Credit Agreement"), among the financial institutions from time to time parties thereto (the "Lenders"), Bank, the other agents parties thereto, Banc of America Securities LLC and GECC Capital Markets Group, Inc., as co-lead arrangers, Banc of America Securities LLC, as sole book manager, Foamex International Inc., Grantor and the Guarantors (as defined therein), Grantor is effecting a permitted sale of certain Designated Assets (as defined in the Credit Agreement), including without limitation the Released Trademarks.

NOW, THEREFORE, in exchange for good and valuable consideration, the receipt of which is hereby acknowledged, the Bank does hereby release, relinquish and discharge its security interest in, to and under the Released Trademarks and in the goodwill of the business symbolized thereby and other rights connected with the use of the Released Trademarks. The foregoing shall not constitute a release, relinquishment or discharge by Bank in any collateral other than the Released Trademarks.
