TRADEMARK AND DOMAIN NAME ASSIGNMENT

This TRADEMARK AND DOMAIN NAME ASSIGNMENT (this "Assignment") is effective this 11 day of October, 2005 ("Effective Date") by and between Wyndham International Inc., a Delaware corporation, Wyndham IP Corporation, a Delaware corporation (successor-in-interest to Wyndham Hotel Company, Ltd.), Wyndham 58th Street, L.L.C., a Delaware limited liability company, and Grand Bay Management Company, a Florida corporation (successor-in-interest to CSMC of Coconut Grove, Inc. and G.B.M. Companies) (together "Assignors") and Hotel TM Corp., a Delaware corporation ("Assignee").

WHEREAS, Assignors hold the trademarks and service marks, including the registrations, applications and common law marks listed on Schedule A attached hereto (the "Trademarks") and the Internet domain name registrations listed on Schedule B attached hereto (the "Domain Names");

WHEREAS, Assignors together with certain other Sellers named therein, and Assignee have entered into that certain Asset Purchase Agreement, dated as of September 13, 2005 (as the same may be amended, modified and/or supplemented from time to time, the "Purchase Agreement");

WHEREAS, the Purchase Agreement provides that (i) Assignors shall assign, transfer, convey and deliver to Assignee and (ii) Assignee shall acquire, all of the right, title and interest of Assignors in, to and under the Trademarks and Domain Names, each in connection with the operation of the Business and all upon the terms and subject to the conditions set forth therein;

WHEREAS, pursuant to the Purchase Agreement, Assignors and Assignee have entered into that certain Trademark and Domain Name Assignment Agreement, dated as of October __, 2005 (the "Assignment Agreement") whereby Assignors assigned, transferred, conveyed and delivered to Assignee and Assignee acquired from Assignors all of Assignors' right, title and interest in, to and under the Trademarks and Domain Names, including any goodwill appurtenant thereto or symbolized thereby.


NOW, THEREFORE, in consideration of the foregoing recitals and the promises and the mutual covenants contained herein and in the Purchase Agreement and the Assignment Agreement, the receipt and sufficiency of which is hereby acknowledged, the parties agree as follows:

1. Assignors hereby assign, transfer, convey and deliver to Assignee, in perpetuity, any and all of Assignors' right, title and interest in, to, and under (i) the Trademarks, including all registrations therefor and renewals thereof, (ii) the Domain Names, (iii) any and all intellectual property and other proprietary rights in and to such Trademarks and Domain Names, including all goodwill appurtenant thereto or symbolized thereby, (iv) any and all numerical internet protocol address associated with or related to the Domain Names and (v) any and all Legal Actions and rights and remedies at law or in equity, including the right to sue for, collect and retain all damages, profits, proceeds, and all other remedies for past infringements.
