**RELEASE OF SECURITY AGREEMENT**

This Release of Security Agreement dated July 10, 2003, made by WELLS FARGO BUSINESS CREDIT, INC., a Minnesota corporation, ("Secured Party") to Spectrum Naturals [sic], Inc., a California corporation, with its business at 1304 South Point Boulevard, Petaluma, California 94954 ("Debtor").

WHEREAS, Secured Party and Debtor entered into a Patent and Trademark Security Agreement ("Agreement") which was secured by, inter alia, the granting by Debtor to Secured Party of a security interest in certain Trademarks of the Debtor (collectively "the Collateral"), to secure the obligations of Debtor under the Credit Agreement; and

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Secured Party does hereby release its security interest in the collateral noted on Exhibit A and any right, title, and interest of the Secured Party in the collateral noted on Exhibit A shall hereby cease and terminate.
