TERMINATION AND RELEASE OF SECURITY INTERESTS IN

TRADEMARKS AND COPYRIGHTS ("Release") dated as of the 19 day of December 2005, by **CITICORP USA, INC.**, a Delaware corporation having an office at 153 East 53rd Street, New York, NY 10043 (the "Lender") (as defined in the Memorandum of Security Interest In Copyrights and Trademark Collateral Security and Pledge Agreement referred to below) and **DEVILLIER DONEGAN ENTERPRISES, L.P.** ("DDE") a Delaware limited partnership having its principal executive offices at 4401 Connecticut Avenue, Washington, DC 20008.

WITNESSETH:

WHEREAS, on March 6, 2002, DDE entered into (a) a Memorandum of Security Interest in Copyrights (the "**Copyright Agreement**") and (b) a Trademark Collateral Security and Pledge Agreement (the "**Trademark Agreement**" and together with the Copyright Agreement, the "**Security Agreements**") with the Lender pursuant to which DDE granted a security interest to Lender in certain collateral as defined in said Security Agreements, including the United States trademark registrations listed in Exhibit I hereto and United States copyright registrations and applications listed in Exhibit II hereto;

WHEREAS, the Trademark Agreement was recorded in the United States Patent and Trademark Office at reel/frame 002462/0966; and

WHEREAS, the Copyright Agreement was recorded in the United States Copyright Office at volumes/pages set forth in Exhibit II; and

WHEREAS, DDE has satisfied all of its obligations to Lender and Lender wishes to release its security interest in the United States trademark registration listed in Exhibit I and United States copyright registrations and applications listed in Exhibit II ;

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged:

1. Lender hereby releases its lien and security interest and any other right, title and interest which it may have in and to all of the United States trademark registrations and applications listed on Exhibit I and all of the United States copyright applications and registrations listed on Exhibit II.


