Release of Lien on Trademarks

This Release of Lien on Trademarks (the "Release"), dated as of March 30, 2006, is made by Wilmington Trust Company, as collateral trustee under the Collateral Agreement referenced below (in such capacity, the "Collateral Trustee"), in favor of Panavision Inc., Panapage One LLC, Panapage Two LLC, Panapage Co. LLC, Panapage International, L.P., Panavision U.K. Holdings, Inc., Panavision Remote Systems, LLC and Las Palmas Productions, Inc. ("together, the Grantors").

WHEREAS, Grantors entered into a Collateral Agreement, dated as of January 16, 2004, and recorded in the United States Patent and Trademark Office as of January 26, 2004, at Reel 2784, Frame 0537, pursuant to which Grantors granted to the Collateral Trustee a security interest in and lien on all right, title and interest of the Grantors in certain trademarks, including the trademark registrations and applications set forth on Schedule A attached hereto (the "Released Trademarks") to secure the performance of certain obligations (the "Obligations");

WHEREAS, the Obligations have now been satisfied, Grantors have requested that the Collateral Trustee release any and all interest it may have in the Released Trademarks, and the Collateral Trustee has agreed to do so.

NOW, THEREFORE, in exchange for good and valuable consideration, the receipt of which is hereby acknowledged, the Collateral Trustee does hereby release, relinquish and discharge its security interest in, to and under the Released Trademarks.


