**TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS**

This TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS ("Termination") is executed and delivered as of March 21, 2006 by Deutsche Bank Trust Company Americas, as Collateral Agent ("Lender"), to Argosy Gaming Company, a Delaware corporation ("Argosy").

**BACKGROUND**

A. On October 3, 2005, Argosy, Penn National Gaming, Inc., Pennsylvania National Turf Club, Inc., Louisiana Casino Cruises, Inc., Hollywood Casino Corporation, BSL, Inc. and BTN, Inc. executed and entered into a Trademark Security Agreement in favor Lender ("Trademark Security Agreement").

B. Pursuant to the Trademark Security Agreement, Argosy granted to Lender a security interest in the trademarks set forth on Exhibit A attached hereto (the "Security Interest").

C. The Security Interest, as amended pursuant to the Security Agreement, was recorded in the United States Patent and Trademark Office ("USPTO") as set forth on Exhibit A attached hereto.

NOW THEREFORE, with the foregoing Background incorporated by reference and intending to be legally bound hereby, the parties agree as follows:

1. Lender terminates and releases all of its rights, titles and interests in the trademarks set forth on Exhibit A.
2. Argosy, or its designee, may record this Termination in the USPTO and in any other trademark offices as may necessary to carry out the intentions of this Termination.
3. The Lender agrees to execute and deliver such other documents as may be reasonably requested and prepared to carry out the intentions of this Termination.
