**COLLATERAL ASSIGNMENT OF TRADEMARKS
TERMINATION AND RELEASE**

This TERMINATION AND RELEASE ("Termination and Release") is dated April 4, 2006 and made by Robertson-Ceco Corporation, a Delaware Corporation ("Debtor"), and Wells Fargo Bank, N.A., a national banking association, as agent ("Agent") for the banks ("Banks") that are or become party to the Loan Agreement referenced below (Agent and the Banks are, collectively, "Lender").

WITNESSETH

WHEREAS, on November 8, 1990, Debtor and Lender entered into a loan agreement (the "Loan Agreement"), whereby Lender agreed to extend credit facilities to Debtor. The obligations of Debtor to Lender under the Loan Agreement were secured by a security interest granted by Debtor in favor of Lender pursuant to the Borrower Security Agreement of the same date (the "Security Agreement");

WHEREAS, the Loan Agreement provides, as a condition precedent to Lender's obligations to extend credit facilities to Debtor, that Debtor grant a security interest in and assignment of the Trademarks (as defined below), under the terms and conditions set forth in the Collateral Assignment of Trademarks dated November 8, 1990 (the "Collateral Assignment");

WHEREAS, Debtor and Agent signed a Supplement to Collateral Assignment of Trademarks on June 30, 1991 (the "Supplement") and a Modification to Collateral Assignment of Trademarks on January 31, 1992 (the "Modification") (the Collateral Assignment, Supplement, and Modification are collectively the "Assignment");

WHEREAS, the Collateral Assignment, Supplement, and Modification were recorded at the United States Patent and Trademark Office on November 9, 1990, at Reel 0772/Frame 0319; on July 24, 1991, at Reel 0801/Frame 0572; and on March 6, 1992, at Reel 0857/Frame 0891;

WHEREAS, the Debtor has made indefeasible payment in full to the Lender, and the Lender has agreed to terminate and release all security interests in the Debtor's Trademarks;

WHEREAS, the Agent has terminated the Assignment and released the continuing security interests in the Trademarks (as defined below), which Debtor had previously granted to Lender; and

NOW, THEREFORE, in consideration of the premises set forth herein and for other good and valuable consideration, receipt and sufficiency of which are hereby acknowledged, and upon the terms set forth in this Termination and Release, Lender hereby terminates and releases the security interests in the Trademarks (as defined below), including the trademarks and trademark applications listed on the attached Schedule A, as follows:

1. Definitions. Unless otherwise defined herein or the context otherwise requires, terms used in this Termination and Release have the meanings provided in the Loan Agreement, Security Agreement, and Assignment.

2. Release of Security Interests. Lender has terminated and released all security interests in the Debtor's Trademarks, including its security interest in the trademarks listed on the attached Schedule A to the Assignment and the following property:

(a) all of Debtor's now-existing, or hereafter acquired, right, title, and interest in and to all of Debtor's trademarks, trade names, trade styles, and service marks; all prints and labels on which said trademarks, trade names, trade styles, and service marks appear, have appeared, or will appear, and all designs and general intangibles of a like nature; all applications, registrations, and recordings relating to the foregoing in the United States Patent and Trademark Office or in any similar office or agency of the United States, and State thereof, any political subdivision thereof, or in any other countries, and all reissues, extensions, and renewals thereof, including those trademarks, terms, designs, and applications described in Schedule A hereto (the "Trademarks");

(b) the good will of the business symbolized by each of the Trademarks, including, without limitation, all customer lists and other records relating to the distribution of products or services bearing the Trademarks; and

(c) any and all proceeds of any of the foregoing, including, without limitation, any claims by Debtor against third parties for infringement of the Trademarks or any licenses with respect thereto.

IN WITNESS WHEREOF, the Lender has duly executed this Termination and Release as of the above date.
