**RELEASE OF SECURITY INTEREST IN  
INTELLECTUAL PROPERTY COLLATERAL**

This RELEASE, dated as of October \_\_, 2005, is made by CREDIT SUISSE, Cayman Islands Branch (formerly known as CREDIT SUISSE FIRST BOSTON, acting through its Cayman Islands Branch), as collateral agent ("CSFB"), pursuant to the termination of the Guarantee and Collateral Agreement (the "Agreement"), by and among, CSFB, DOANE PET CARE COMPANY, F/K/A WINDY HILL PET FOOD CO. and DOANE PET CARE ENTERPRISES, INC., both Delaware corporations (the "Grantors").

**WITNESSETH**

WHEREAS, pursuant to the Trademark Security Agreement (the "Security Agreement") by and among the Grantors and CSFB, dated November 5, 2004 and recorded with the U.S. Patent and Trademark Office on November 22, 2004 at Reel/Frame Nos. 2979/0084, 2979/0150, and 2979/0307, the Grantors granted CSFB a security interest in its trademarks, registered trademarks, trademark applications, service marks, registered service marks and service mark applications, together with any goodwill connected with and symbolized by any such trademarks, registered trademarks, trademark applications, service marks, registered service marks, service mark applications; and all rights and interests pursuant to licenses or other contracts in favor of such Grantor pertaining to any trademarks, trademark registrations or trademark rights (the "Trademark Collateral");

WHEREAS, CSFB acknowledges full payment, complete performance and satisfaction of all obligations pursuant to the Agreement secured by the Security Agreement have been made;


WHEREAS, the Grantors have requested that CSFB release its security interest in the Trademarks, as defined in the Security Agreement in connection with the termination of the Agreement, and the Security Agreement (the "Released Collateral").


NOW, THEREFORE, in consideration of the foregoing, CSFB hereby RELEASES, without recourse, all of its security interest in the Trademarks, listed on Schedule I attached hereto and incorporated herein by reference, and any other collateral described in the Security Agreement.


