TERMINATION AND RELEASE OF  
SECURITY INTEREST IN PATENTS, TRADEMARKS AND COPYRIGHTS

WHEREAS, pursuant to that certain Amended and Restated First Lien Security Agreement, dated September 27, 2005 (the "Security Agreement"), by US Airways, Inc., the other Grantors party thereto (together with US Airways, Inc., the "Grantors") in favor of Wilmington Trust Company, as Collateral Agent (the "Grantee"), Grantors granted a security interest in, among other collateral, certain intellectual property of Grantors to Grantee for itself and for the ratable benefit of the Secured Parties;

WHEREAS, pursuant to that certain Amended and Restated First Lien Intellectual Property Security Agreement, dated as of September 27, 2005 (the "IP Security Agreement"), by the Grantors in favor of the Grantee, as Collateral Agent, as security for the prompt payment in full and the performance and observance of the Secured Obligations of the Grantors, the Grantors granted, bargained, sold, assigned, transferred, conveyed, mortgaged, pledged and confirmed, unto Grantee, its successors and assigns, for the ratable security and benefit of the Secured Parties, a Lien on and security interest in all estate, right, title and interest of such Grantor in, to and under the following, whether then owned or thereafter acquired, and wherever located (the "Collateral"):

- (a) the patents and patent applications set forth in Schedule A hereto;
- (b) the trademark and service mark registrations and applications set forth in Schedule B hereto (provided that no security interest was granted in United States intent-to-use trademark applications to the extent that, and solely during the period in which, the grant of a security interest therein would have impaired the validity or enforceability of such intent-to-use trademark applications under applicable federal law), together with the goodwill symbolized thereby;
- (c) the copyright registrations and applications and exclusive copyright licenses set forth in Schedule C hereto;
- (d) all reissues, divisions, continuations, continuations-in-part, extensions, renewals and reexaminations of any of the foregoing, all rights in the foregoing provided by international treaties or conventions, all rights corresponding thereto throughout the world, and all other rights of any kind whatsoever of such Grantor accruing thereunder or pertaining thereto;
- (e) any and all claims for damages and injunctive relief for past, present and future infringement, dilution, misappropriation, violation, misuse or breach with respect to any of the foregoing, with the right, but not the obligation, to sue for and collect, or otherwise recover, such damages; and
- (f) any and all Proceeds of any and all of the foregoing.

WHEREAS, the IP Security Agreement was recorded in the United States Patent and Trademark Office, including but not limited to, on September 28, 2005 at Reel/Frame

3165/0956 and on September 28, 2005 at Reel/Frame 3166/0066, and in the United States Copyright Office, the recordations for which have not yet been published.

WHEREAS, Grantors have paid in full and satisfied the Secured Obligations (other than contingent indemnification obligations which are not due and payable) under the Loan Documents, and the Security Agreement and IP Security Agreement have terminated pursuant to their express terms on the Termination Date, and Grantee has agreed to release its security interest in the Collateral and assign, transfer and deliver to Grantors such of the Collateral as may be in the possession of the Grantee and as has not theretofore been sold or otherwise applied or released pursuant to the Security Agreement or IP Security Agreement.

WHEREAS, the Grantee wishes to provide a document suitable for recording in the United States Patent and Trademark Office and in the United States Copyright Office for purposes of recording the release, relinquishment and discharge of its security interest in the Collateral, including, without limitation, the Patents, the Trademarks and the Copyrights;

NOW THEREFORE, in consideration of the premises and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Grantee does hereby agree as follows:

1. Authority of Grantee. Grantee acknowledges that it is authorized to execute this Termination and Release of Security Interest in Patents, Trademarks and Copyrights in its capacity as Collateral Agent in accordance with the Security Agreement and the IP Security Agreement.

2. Termination and Release. The Grantee acknowledges the satisfaction and termination of the Lien and the security interests granted under the Security Agreement and IP Security Agreement and assigns, transfers and delivers to Grantors such of the Collateral as may be in the possession of the Grantee and as has not theretofore been sold or otherwise applied or released pursuant to the Security Agreement and hereby releases its entire estate, right, title and interest in the Collateral to Grantors and reverts Grantors with full estate, right, title, and interest to the Collateral. Grantee acknowledges and agrees that, as a result of this Termination and Release of Security Interest in Patents, Trademarks and Copyrights, it has no further rights to or interest in the Collateral.

3. Further Assurances. The Grantee hereby agrees, at the Borrower's expense, to execute such instruments and to take such other actions as the Grantors may reasonably request to terminate the Grantee's security interest in the Collateral, and otherwise to effectuate the release of the Collateral from the Grantee's security interest.

4. Recordation. The Grantee hereby authorizes and requests the governing body of each of the United States Patent and Trademark Office and the United States Copyright Office to record this termination and release of security interest in the Collateral.

5. Governing Law. This Termination and Release of Security Interest in Patents, Trademarks and Copyrights shall be governed by and construed and interpreted in accordance with the laws of the State of New York.

6. Definitions. Capitalized terms used herein and not defined shall have the respective meaning ascribed to such terms in the Security Agreement or the IP Security Agreement as applicable.

7. Execution in Counterparts. This Termination and Release of Security Interest in Patents, Trademarks and Copyrights may be executed in any number of counterparts, each of which when so executed shall be deemed to be an original and all of which taken together shall constitute one and the same agreement.
