

RELEASE OF SECURITY INTEREST IN DOMESTIC TRADEMARKS

KNOW ALL MEN BY THESE PRESENTS, that WACHOVIA BANK, NATIONAL ASSOCIATION, successor by merger to Congress Financial Corporation (Florida), in its capacity as agent ("Secured Party"), having an office at 110 East Broward Boulevard, Fort Lauderdale, Florida 33301, DOES HEREBY CERTIFY that the security interests it holds in the trademarks and trademark applications of FINANZ ST. HONORE B.
