**ASSIGNMENT OF TRADEMARK**

NOW THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, ASSIGNOR does hereby assign, convey, transfer, deliver, set over and vest to and in ASSIGNEE, its successors and assigns, absolutely and forever, this entire right, title and interest, whether statutory or common law, in and to the mark WEATHERPROOF KIDS, and all the rights and privileges related thereto including but not limited to the priority rights arising from said application and mark, the right to recover and take all such proceedings as may be necessary for the recovery of damages or otherwise in respect of past, present and future

infringement and dilution, together with that part of the goodwill of the business connected with the use of and symbolized by the mark WEATHERPROOF KIDS throughout the world.
