**SUPPLEMENTAL GRANT OF SECURITY INTEREST
IN PATENTS, TRADEMARKS AND LICENSES**

WHEREAS, Complex Media THC LLC ("Complex"), Zoo York, L.L.C. ("Zoo"), Femme Arsenal THC LLC ("FATHC"), and Yakira, L.L.C. ("Yakira" and together with Complex, Zoo and FATHC, collectively, the "Company"), own the trademarks and trademark applications shown in the attached Schedule A (the "Trademarks"), for which there are recordings or applications in the United States Patent and Trademark Office under the numbers shown in the attached Schedule A; and

WHEREAS, Company is obligated to The CIT Group/Commercial Services, Inc. ("CIT") and various other financial institutions (collectively, "Lenders") and CIT as agent for Lenders ("Agent"), pursuant to (i) a certain Second Amended and Restated Guaranty dated as of the date hereof made by Complex, FATHC, Yakira and the other entities made a party thereto in favor of Agent, (ii) a certain Amended and Restated Grant of Security Interest in Patents, Trademarks and Licenses, dated as of April 8, 2004, made by the Company in favor of Agent and (iii) a certain Second Amended and Restated Financing Agreement dated as of the date hereof among Zoo, Agent and the other entities made a party thereto (as each may be amended, modified, restated or supplemented from time to time, collectively, the "Agreements"); and

WHEREAS, pursuant to the Agreements, Company is granting to Agent for its benefit and for the ratable benefit of Lenders a security interest in the Trademarks, all proceeds thereof, all rights corresponding thereto and all reissues, divisions, continuations, renewals, extensions and continuations-in-part thereof, and the recordings and applications therefore.

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, Company does hereby confirm its previous grant to Agent, for its benefit and for the ratable benefit of Lenders, of a continuing first priority security interest in and to the Trademarks and recordings and applications therefor, which security interest shall secure all the Obligations as defined in the Agreements and in accordance with the terms and provisions thereof.




