WHEREAS, pursuant to the Security Agreement, each Grantor has agreed with the Administrative Agent to execute this Short-Form United States Trademark Security Agreement; and

WHEREAS, terms defined in the Security Agreement are used herein as defined therein;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, each Grantor hereby grants to the Administrative Agent, for the benefit of the Lenders and Administrative Agent, according to the terms of the Security Agreement, a security interest in all of its right, title and interest in, to and under all the Trademark Collateral of such Grantor located in the United States of America, together with, among other things, the good-will of the business symbolized by the trademarks, including its respective trademarks listed on the attached Schedule I, and all registrations and pending applications associated therewith, as collateral security for the prompt and complete payment and performance when due of all the Secured Obligations.


