RELEASE OF GRANT OF SECURITY INTEREST IN TRADEMARK RIGHTS


This Release of Grant of Security Interest in Trademarks (the "Release"), dated as of April 12, 2006 is made in favor of ForMost, Inc., a Delaware corporation (the "Grantor") by UBS AG, Stamford Branch, a company organized under the laws of Switzerland, as Administrative Agent and Collateral Agent (the "Administrative Agent") for the several banks and other financial institutions party to the Credit Agreement dated as of March 4, 2004 (as amended, supplemented or otherwise modified from time to time, the "Credit Agreement"), among Multiplan, Inc., the Lenders, the Administrative Agent, and the other agents parties thereto. Capitalized terms not defined herein shall have the meanings ascribed to them in the Credit Agreement.

WHEREAS, in connection with a Guarantee and Collateral Agreement dated as of March 4, 2004, Grantor entered into a Grant of Security Interest in Trademark Rights, dated as of March 4, 2004 and recorded in the United States Patent and Trademark Office as of March 15, 2004 at Reel 2810, Frame 0589 pursuant to which Grantor granted to the Administrative Agent a security interest in and lien on all right, title and interest of the Grantor in certain trademarks, including the trademark registrations and applications set forth on Schedule A attached hereto (the "Released Trademarks") to secure the performance of certain obligations (the "Obligations");

WHEREAS, the Obligations have now been satisfied, Grantor has requested that the Administrative Agent release any and all interest it may have in the Released Trademarks, and the Administrative Agent has agreed to do so.

NOW, THEREFORE, in exchange for good and valuable consideration, the receipt of which is hereby acknowledged, the Administrative Agent does hereby release, relinquish and discharge its security interest in, to and under the Released Trademarks.

IN WITNESS WHEREOF, the Administrative Agent has caused this Release to be duly executed and delivered by its officer thereunto duly authorized as of the date hereinabove set forth.
