**ASSIGNMENT OF TRADEMARKS  
AND TECHNICAL INFORMATION**

THIS ASSIGNMENT OF TRADEMARKS AND TECHNICAL INFORMATION ("Assignment"), is made and effective as of the 3<sup>rd</sup> day of May, 2006, by and between BOUDREAUX'S FAMILY PHARMACY, INC. d/b/a BOUDREAUX'S BUTT PASTE, a corporation organized under the laws of the State of Louisiana having an office at 13405 Seymour Myers Blvd, Suite 29, Covington, Louisiana 70433 ("Assignor"), and BLAIREX LABORATORIES, INC., a corporation organized under the laws of the State of Indiana having an office at 3240 North Indianapolis Road, Columbus, Indiana 47201 ("Assignee").

WITNESSETH

Assignor's assignment of the Technical Information and Trademarks affected by this Assignment is made pursuant to, and is subject to the terms of, the Purchase Agreement and nothing in this Assignment or such other instrument or deed of assignment shall be construed or interpreted as superseding the provisions of the Purchase Agreement.
