GRANT OF SECURITY INTEREST IN TRADEMARKS

This Grant of Security Interest in Trademarks, dated as of October 13 2005, is made between Grantors listed on the signature pages hereof (collectively, jointly and severally, "Grantors" and individually, "Grantor") and WILMINGTON TRUST COMPANY, 1100 North Market Street, Rodney Square North, Wilmington, DE 19890, in its capacity as Collateral Agent ("Secured Party").

WHEREAS, Grantors are the owner of the Trademarks and Trademark registrations identified on Schedule A attached hereto (collectively the "Trademarks"); and

WHEREAS, Grantors are obligated to Secured Party under the terms of a certain Common Security Agreement between Grantors and Secured Party dated as of October 13, 2005 (the "Common Security Agreement");

NOW THEREFORE, pursuant to the Common Security Agreement and in order to induce the Secured Party to enter into the Common Security Agreement, Grantor does hereby grant Secured Party a security interest in all Grantor's right, title and interest in and to: (i) the Trademarks, including all applications or registrations therefor; (ii) all income, royalties, damages and payments now due or payable or which hereafter become due or payable in respect to thereto; (iii) all causes of action (in law or equity) and rights to sue, counterclaim and/or recover for past, present or future infringement thereof; and (iv) all rights corresponding to the foregoing throughout the world.

Each Grantor hereby agrees to execute all papers and to perform all other proper acts requested by Secured Party or its successors or assigns to secure to Secured Party or its successors or assigns the rights hereby transferred.

Each Grantor does hereby acknowledge and affirm that the rights and remedies of Secured Party with respect to the foregoing security interest in the Trademarks made and granted hereby are more fully set forth in the Common Security Agreement, the terms and provisions of which are hereby incorporated herein by reference as if fully set forth herein, and that this document is subject to the terms and conditions of the Common Security Agreement.

Notwithstanding anything contained herein to the contrary, it is expressly understood and agreed by the parties hereto that this Grant of Security Interest in Trademarks is executed and delivered by Wilmington Trust Company, not individually or personally, but solely as Collateral Agent, in the exercise of the powers and authority conferred and vested in it under the Common Security Agreement.
