AMENDMENT NO. 1 TO PATENT AND TRADEMARK SECURITY AGREEMENT

THIS AMENDMENT NO. 1 TO PATENT AND TRADEMARK SECURITY AGREEMENT (this "Amendment"), dated as of May 5, 2006, is entered into by and between BANK OF AMERICA, N.A. ("Bank of America"), as Agent for the Lenders referred to below ("Secured Party") and BRADSHAW INTERNATIONAL, INC., a California corporation ("Debtor"), with reference to the following facts:

RECITALS

A. Debtor and Butler Home Products, LLC, a Delaware limited liability company (collectively with Debtor, the "Borrowers") entered into that certain Loan and Security Agreement dated as of February 14, 2003 (as amended from time to time, the "Prior Loan Agreement"), by and among Borrowers, the lenders from time to time a party thereto, and Banc of America Leasing & Capital, LLC (successor-in-interest to Fleet Capital Corporation) ("BALC"), as agent ("Prior Agent"). BALC has assigned all if its right, title and interest in and to the Prior Loan Agreement, the related loan documents and the credit facility evidenced thereby to Bank of America.

B. In connection with the Prior Loan Agreement, Debtor entered into that certain Patent and Trademark Security Agreement dated as of February 14, 2003, in favor of Prior Agent (as amended, restated, supplement, or otherwise modified, the "Security Agreement").

C. BALC has assigned all of its right, title and interest in and to the Prior Loan Agreement, the related loan documents and the credit facility evidenced thereby to Bank of America.

D. Borrowers entered into an Amended and Restated Loan and Security Agreement dated as of March 2, 2006, among Borrowers, the lenders from time to time a party thereto (each a "Lender: and collectively, the "Lenders"), and Secured Party (as amended, extended, renewed, supplemented, or otherwise modified from time to time, the "Loan Agreement").

E. Debtor and Secured Party wish to amend the Security Agreement as set forth below.

NOW, THEREFORE, the parties hereby agree as follows:

1. Defined Terms. Any and all initially capitalized terms used in this Amendment without definition shall have the respective meanings specified in the Security Agreement.

2. Amendment to Recital A. Recital A is amended and restated in its entirety to read as follows:

A. Pursuant to the Amended and Restated Loan and Security Agreement, dated as of March 2, 2006, by and among Debtor, Butler Home Products, LLC, a Delaware limited liability company ("collectively with Debtor, the "Borrowers"), the lenders from time to time a party thereto (collectively, the "Lenders" and individually, a "Lender"), and Secured Party (as amended, extended, renewed, supplemented, or otherwise modified from time to time, the "Loan Agreement"), the Lenders have agreed to extend certain credit facilities to the Borrowers.

3. Amendment to Schedule A – Patents and Patent Applications. Schedule A to the Security Agreement is hereby amended and replaced by Schedule A attached hereto as Annex 1.

4. Amendment to Schedule B – Trademarks and Service Marks. Schedule B to the Security Agreement is hereby amended and replaced by Schedule B attached hereto as Annex 2.

5. Conditions Precedent. The effectiveness of this Amendment shall be subject to the Secured Party's receipt of an original of this Amendment, duly executed by Debtor.

6. Miscellaneous.

(a) Survival of Representations and Warranties. All representations and warranties made in the Security Agreement or in any other document or documents relating thereto, including, without limitation, any Loan Document furnished in connection with this Amendment, shall survive the execution and delivery of this Amendment.

(b) Reference to Trademark Security Agreement. The Security Agreement, each of the other Loan Documents, and any and all other agreements, documents or instruments now or hereafter executed and delivered pursuant to the terms hereof, or pursuant to the terms of the Loan Agreement, are hereby amended so that any reference therein to the Security Agreement shall mean a reference to the Security Agreement as amended by this Amendment.

(c) Loan Agreement Remains in Effect. The Loan Agreement and the other Loan Documents remain in full force and effect and Debtor ratifies and confirms its agreements and covenants contained in each Loan Document to which it is a party.

(d) Severability. Any provision of this Amendment held by a court of competent jurisdiction to be invalid or unenforceable shall not impair or invalidate the remainder of this Amendment and the effect thereof shall be confined to the provision so held to be invalid or unenforceable.

(e) Counterparts. This Amendment may be executed in one or more counterparts, each of which when so executed shall be deemed to be an original, but all of which when taken together shall constitute one and the same instrument. [Delivery of executed counterparts to the documents described in Section 5 by telecopy or electronic mail shall be effective as delivery of originally executed counterparts, provided that such originally executed counterparts shall be delivered to Secured Party as promptly as practicable, but in no event later than 5 business days following the date hereof.]

(f) Headings. The headings, captions and arrangements used in this Amendment are for convenience only and shall not affect the interpretation of this Amendment.


(g) NO ORAL AGREEMENTS. THIS AMENDMENT, TOGETHER WITH THE OTHER LOAN DOCUMENTS AS WRITTEN, REPRESENTS THE FINAL AGREEMENT AMONG SECURED PARTY AND DEBTOR AND MAY NOT BE CONTRADICTED BY EVIDENCE OF PRIOR, CONTEMPORANEOUS OR SUBSEQUENT

ORAL AGREEMENTS OF THE PARTIES. THERE ARE NO UNWRITTEN ORAL AGREEMENTS AMONG SECURED PARTY AND DEBTOR.
