COLLATERAL ASSIGNMENT FOR SECURITY

TRADEMARKS

WHEREAS, each of the undersigned (each a "Grantor") has adopted, used and is using, and holds all right, title and interest in and to, the trademarks and service marks of such Grantor listed on the annexed Schedule 1A, which trademarks and service marks are registered or applied for in the United States Patent and Trademark Office (the "Trademarks");

WHEREAS, each Grantor has entered into a Security Agreement, dated September 29, 2005 (as amended, restated, supplemented, renewed, extended, replaced or otherwise modified from time to time, the "Security Agreement"), in favor of Silver Point Finance, LLC, a Delaware limited liability company, as collateral agent for certain lenders (in such capacity, together with any successors and assigns, the "Collateral Agent");

WHEREAS, pursuant to the Security Agreement, each Grantor has granted to the Collateral Agent for the benefit of the Agents and the lenders (as such terms are defined in the Security Agreement), a continuing security interest in all right, title and interest of such Grantor in, to and under the Trademarks, together with, among other things, the good-will of the business symbolized by the Trademarks and the applications and registrations thereof, and all proceeds thereof, including, without limitation, any and all causes of action which may exist by reason of infringement thereof and any and all damages arising from past, present and future violations thereof (the "IP Collateral"), to secure the payment, performance and observance of the Obligations (as defined in the Security Agreement);

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, each Grantor hereby pledges and assigns to the Collateral Agent, and grants to the Collateral Agent, for the benefit of the Agents and the Lenders, a continuing security interest in such Grantor's IP Collateral to secure the prompt payment, performance and observance of the Obligations.

Each Grantor does hereby further acknowledge and affirm that the rights and remedies of the Collateral Agent with respect to the IP Collateral are more fully set forth in the Security Agreement, the terms and provisions of which are hereby incorporated herein by reference as if fully set forth herein.

IN WITNESS WHEREOF, each Grantor has caused this Assignment to be duly executed by its officer thereunto duly authorized as of September 29 2005.
